

BONUS INCENTIVE **FOR 2020**

LIMITED-TIME OFFER FOR INDUSTRIAL AND AGRICULTURAL CUSTOMERS

Energy Trust of Oregon helps Oregon businesses save energy and money by providing cash incentives for energy-efficient models of the equipment you use every day. Through December 31, 2020, Energy Trust is offering a bonus incentive to industrial and agricultural customers who complete an eligible upgrade.

Base incentive	+Bonus incentive	=Total incentive*
\$0.30 per kWh or \$2.50 per therm, up to 70% of eligible measure costs	\$0.10 per kWh or \$0.75 per therm, up to 30% of eligible measure costs	\$0.40 per kWh or \$3.25 per therm, up to 100% of eligible measure costs

**The incentive may not exceed Energy Trust's incentive limits on a per-project or per-site, per-year basis.*

What measures are eligible for the bonus?

- Cannabis indoor grow insulation
- Compressed air upgrades (≤ 125 hp)
- Cooling tower fan variable frequency drive (VFD) (≤ 100 hp)
- Dairy vacuum pump VFDs and pre-cooler heat exchangers
- Greenhouse boiler and envelope upgrades
- High-speed doors for refrigerated space
- Industrial fan VFDs (supply, exhaust, dust collection, etc.) (≤ 100 hp)
- Industrial/municipal pump upgrades and VFDs (≤ 100 hp)
- Municipal water leak repair
- Process hot water boiler ($\leq 3,000,000$ btu/hr)
- Refrigeration controllers (rack units up to two compressors; no limitation for packaged split units)

Eligibility and requirements:

- Bonus incentive is available to customers who submit a signed incentive offer, Form 420SI: Incentive Application, for an eligible measure after May 4, 2020. The measure must meet the requirements detailed on the application.
- Customers must submit Form 440C: Project Completion Certificate and all required project completion documentation to Energy Trust by the Incentive reservation expiration date, or the bonus deadline, whichever comes first.
- Customer must install the qualifying upgrade at an eligible site served by Portland General Electric, Pacific Power, NW Natural, Cascade Natural Gas or Avista. Contact Energy Trust to confirm your site is eligible.
- Standard industrial and agriculture measures eligible for rebates cannot receive this bonus.
- Incentives are subject to availability and may change. Pre-incentive project payback must be greater than 1 year to be eligible. Final incentives paid by Energy Trust may vary and will be based upon the final installed project measures, project costs, and identified energy savings.

Bonus incentive \$3.25 per therm or up to 100% of measure costs	<ul style="list-style-type: none">• \$22,200 incentive• Immediate return on investment
