Total Annual Results

- Energy Trust's 478 aMW gen/saved + 28.2m therms
- 508,000 sites served
- Direct benefit of \$1.3 billion saved on customer energy bills
- Benefits to all ratepayers = \$1.58 billion in deferred utility investment
- Independent study shows \$2.7 billion added to Oregon economy







Trade Ally Network

Attracted and supported a network of over 1,700 contractors and 950 engineers, architects, realtors and other professionals

- Businesses range in size from
 1 to 200+ employees
- 74% employ 10 workers or less
- 145 are currently Minority,
 Women and Emerging Small Business certified
- Adding lender allies









Keeping our Air Cleaner



- Eliminated 8.4 million tons of carbon dioxide from our atmosphere
- Equivalent to removing
 1.5 million cars from our roads for a year





Q1 2013 Results – Big Picture

- Lag time in capturing energy-efficiency savings
 - Transitions to new PMCs and new data entry and verification processes
 - Time needed to align with Energy Trust audit standards
 - Delayed projects closing and processing incentive payments
 - Procedures addressed and now in place
- Lower-than-expected renewable energy generation
 - Stagnant commercial solar market
 - Increased commercial solar incentives, expanded allowed system sizes
- Significant activity across most program offerings





Sector Highlights

Commercial

- Slightly behind historical Q1 savings for 3 utilities
- Completed transition to ICF, new Program Management
 Contractor
- 6 companies enrolled in Strategic Energy Management
- Continue coordination with ODOE on Cool Schools initiative
- Supported development of Mpower Oregon pilot
- Positive response to New Buildings Market Solutions offerings
- New Buildings enrolled 115 projects during Q1

Industrial & Agricultural

- Tracked well against historical savings for all utilities
- Market penetration in high-tech sector
- High enrollment in Strategic Energy Management and Refrigeration Operator Coaching



Sector Highlights, continued

Residential

- Savings trending behind historical results
- 400 Clean Energy Works Oregon projects delayed until Q2
- EPS[™] for existing homes; 270 EPS-rated new homes
- 14 solar-ready new homes were completed
- Custom Home Energy Reports
- Existing Homes pilot with MIT

Renewable Energy

- Poor market conditions for many projects
- Residential solar remains strong; commercial stagnant
- Farm Power biogas project reached commercial operation
- RFPs in PGE and Pacific Power territories
- Two projects delayed into 2014





Q1 Customer Service Highlights

- 6,958 calls and 176,890 web visits
- More customers directly calling programs
- Phone and on-site Home Energy Reviews continue
- Provided training for 40 new program representatives to support positive customer experience
- 6 customer complaints received in Q1
- Percent of participants "Satisfied" or "Very satisfied"
 - Nov 2012–Feb 2013 Fast Feedback phone surveys of 761 participants
