

New Buildings I 2020 Net Zero Emerging Leaders Internship Grant

BACKGROUND & OVERVIEW

Energy Trust of Oregon's 2020 Net Zero Emerging Leaders Internship Grant opportunity may provide grant funding to a limited number of selected architecture and engineering firms, serving Oregon, in support of such firms' paid student internships. The grant funds would support internship work that helps the firm meet and track their progress towards tasks related to the firm's American Institute of Architects (AIA) 2030 Commitment, including tracking and reporting project activity through AIA's Design Data Exchange (DDx) platform.

Energy Trust's goals for the 2020 Net Zero Emerging Leaders Internship Grant funding support include:

- Assisting architecture and engineering firms in gaining additional insight on the energy performance of their building designs
- Enabling architecture and engineering firms to establish an AIA 2030 Commitment reporting infrastructure and resources for reporting across a portfolio of projects
- Promoting career development opportunities for emerging and future architecture and engineer professionals; architecture and engineering firm internships can provide students with an understanding of net-zero building design in Oregon as well as real-world experience with the firm's projects
- Encouraging architecture firms to use a diversity, equity, inclusion lens while weighing their intern candidates. For example, some candidates may have had fewer opportunities for career advancement or may represent a demographic that is not proportionally represented amongst professional architects and engineers. Using additional criteria in weighting candidates can enable greater diversity and inclusivity within the building industry, improving future buildings for all Oregonians
- Providing a forum for architecture and engineering firms' Net Zero Emerging Leaders interns to present, to each other and to
 the broader design community on the results of their internships, at a High-Performance Design Training event hosted by
 Energy Trust New Buildings

Energy Trust intends to award up to five grants, of up to \$6,000 each, to help selected architecture and engineering firms with their costs associated with implementing a paid, firm internship that would begin in January 2020 and end in April 2020. To apply, the firm must be located in, and designing buildings in Oregon, and must be an AIA 2030 Commitment signatory or become one by November 2019. Firms that received 2019 Net Zero Emerging Leaders internship grant funding are welcome to apply; however, during the review and evaluation process, Energy Trust will be applying a higher weighting factor towards first-year applicants. APPLICATION REVIEW AND SELECTION PROCESS

Interested architecture and engineering firms should submit a complete grant application, addressing all of the requested information outlined in the **Grant Application Submittal Materials** section below, to newbuildings@energytrust.org as a combined PDF by the close date of **October 11, 2019**. Following this deadline, complete grant applications will be reviewed and evaluated by an Energy Trust New Buildings review team and selected firms will be notified of their award.

The selected architecture and engineering firm(s) will be required to sign a written grant agreement with Energy Trust that details the terms and conditions for the grant funding. No award will be considered a commitment, and no obligations or legal relations shall exist between Energy Trust and any selected applicant until a final and binding written contract has been executed by and between Energy Trust and such selected applicant. Prolonged contract negotiations will not be undertaken; if it appears that contracting negotiations are not proceeding in a timely manner, Energy Trust may opt to terminate the discussions and select another applicant. Any party involved in these contracting discussions can terminate negotiations at any time and for any reason.

Applications must be submitted, by the deadline indicated, to newbuildings@energytrust.org as a single, combined PDF. Please write using 12-point font, with one-inch margins. Applicant must clearly identify the application submission, in both the email subject line and in the document, as a *Net Zero Emerging Leaders Internship Grant Application*.

In the application, please provide the following details:

 - Indicate your firms anticipated costs for employing the intern during the paid 12-week internship hours, noting the
 hours per week your selected intern would be expected to work, including administrative costs if applicable. This
 cost total should equal your requested grant amount, not to exceed a maximum of \$6,000.

Energy Trust will not play any role in a firm's selection or hiring of any intern associated with the Net Zero Emerging Leaders Internship Grant. Grant recipient firms will be solely responsible for hiring and supervising their paid intern, in conformance with all applicable laws and regulations, including without limitation all wage and hour laws.

New Buildings I 2020 Net Zero Emerging Leaders Internship Grant

- The Net Zero Emerging Leaders Internship Grant opportunity is designed to provide career development opportunities for students pursuing a bachelors or master's degree in architecture or engineering
- The approximately 12-week firm internship that is the subject of Energy Trust's Net Zero Emerging Leaders Internship Grant opportunity must be scheduled to begin in January 2020, which is designed to align with both the winter term for students and the March 31, 2020 DDx portfolio submission due date, and end with a conclusion presentation at a New Buildings' hosted event in April 2020
- Energy Trust would expect that a grantee firm's Net Zero Emerging Leaders Internship Grant intern would work a minimum of 120 hours, approximately 10-15 hours per week, over the course of the internship under the supervision of a firm mentor on tasks associated with the firm's Oregon project portfolio and AIA 2030 Commitment
- The Net Zero Emerging Leaders Internship Grant will require that the firm's internship provide its intern with opportunities to develop familiarity with the firm's projects and AIA 2030 Commitment, by directly assisting with entries and updates of the firm's portfolio of Oregon projects into the DDx database by the March 31, 2020 for inclusion in the AIA annual report. Other tasks might include assisting the firm with drawing conclusions from data to inform the future design practices, or creating sustainability metrics and quantifying metrics around company goals as encouraged by the DDx Sustainability Action Plan requirement
- Energy Trust may facilitate 1-2 opportunities for Net Zero Emerging Leaders Internship Grant interns to meet with other Net Zero Emerging Leaders Internship Grant interns to discuss their internships and promote cross learning and would expect grantee firms to support that activity as part of their internship
- All firms receiving a Net Zero Emerging Leaders Internship Grant will be required to have their interns prepare and deliver a
 presentation at an event hosted by Energy Trust New Buildings, in April 2020, on the results of their Net Zero Emerging
 Leaders Internship Grant internships
- Energy Trust Net Zero Emerging Leaders Internship Grant funds will be dispersed to the grantee firm upon completion of all grant deliverables. Among other things, firms will be required to show that the firm's intern was employed and paid for their internship work at the firm and worked at least 120 hours during the internship, that the firm entered the full portfolio of Oregon projects into the DDx database by the March 31, 2020 due date, and that their intern presented at the April 2020 event
- All firms receiving Energy Trust Net Zero Emerging Leaders Internship Grants and their interns will be asked to complete a survey on the grant opportunity and internship to help inform Energy Trust Net Zero Emerging Leaders Grant offering in the future
