**Single family:** Freestanding structure with no attached residences, including detached single-family and manufactured homes.

**Multifamily:** Attached residences such as duplexes, triplexes and fourplexes, and side-by-side townhomes and rowhomes.\*

### WINDOWS + INSULATION

Keep heat in during the winter, out during the summer, and take a load off your heating and cooling system with efficient weatherization upgrades.

#### Windows

Up to \$1.50 per square foot: Based on efficiency rating

#### Insulation (single family)

\$1.50 per square foot: Attic/ceiling

\$0.75 per square foot: Floor, wall

#### Insulation (multifamily)

\$1.25 per square foot: Attic/ceiling

\$0.50 per square foot: Floor, wall†

## HEATING + COOLING

Replacing old, inefficient equipment helps to improve performance while also reducing maintenance costs.

### Smart thermostat

\$80: Select models qualify. Home must be primarily heated with a forced air furnace (electric or gas) or an electric heat pump.

### Gas furnace (single family)

\$1,600 instant discount: 95% AFUE or greater. Must be used as primary heat source. Your trade ally contractor will deduct the incentive amount straight from your invoice.

### Gas furnace (multifamily\*)

\$1,600: 95% AFUE or greater. Must be used as primary heat source.

### Ductless heat pump (single family)

\$1,800 per residence: For homes replacing electric resistance heat in a primary living space, HSPF2 8.55 or greater.

### Ductless heat pump (multifamily\*)

\$1,800 per residence: For homes replacing electric resistance heat in a primary living space, HSPF2 must be 8.55 or greater.

### Heat pump (single family)

\$3,000: HSPF2 must be 7.50 or greater. Must replace baseboard, wall heaters or electric forced air furnace as primary heat source.

### Heat pump (multifamily\*)

\$1,000: HSPF2 must be 7.50 or greater. Must replace electric forced air furnace as primary heat source.

### Heat pump controls

\$250: For qualified advanced controls on existing ducted heat pump systems or new heat pump installations.

### Direct-vent gas fireplace

Up to \$250: Based on Fireplace Efficiency (FE) with electronic pilot ignition.
