APPLICATION: This *Form 610L* must be filled out completely, truthfully and accurately. Builder and Verifier (collectively, "Trade Allies") are advised to retain a copy of this application and any accompanying documentation submitted to Energy Trust of Oregon, Inc. ("Energy Trust") under this program. Energy Trust will not be responsible for lost documentation pertaining to this application request.

ELIGIBILITY: Incentives for Affordable Housing projects are available to Trade Allies building and verifying homes through the EPS New Construction Program in Portland General Electric, Pacific Power, NW Natural, Cascade Natural Gas or Avista territories.

PAYMENT: Affordable Housing Incentives will be paid to the Builder and Verifier upon submission of the completed Builder Affordable Housing Confirmation, along with EPS project application, with all required information filled out. Please allow up to 60 days for receipt of payment after verification and all paperwork is received.

INFORMATION RELEASE: The Trade Alliesunderstand and agree that Energy Trust and/or its representatives may include a description of this application, including the Company Authorized Representative name, the company name, and tax documentation required by the Energy Trust Board of Directors, the Oregon Public Utility Commission, Oregon Department of Energy, Oregon Housing & Community Services, the Oregon Legislature, funding utilities, and/or other government agencies. Energy Trust will treat all other information gathered in evaluations as confidential and report it only in the aggregate, unless a specific disclosure is required by applicable law or governmental or court order.

RURAL: To qualify as "Rural", homes must be sited within Energy Trust Regions 1, 2, 5, 7, 9, 10, or 11, excluding homes within the city limits of Corvallis, Eugene, Springfield, and Hood River. Upon request, a program representative can make exceptions to qualify additional areas as Rural.
