

INSTANT DISCOUNTS FOR BUSINESS LIGHTING

Energy Trust of Oregon can help you save energy and money—and it's as easy as changing a light bulb. Installing new LED lighting is an excellent way to enhance lighting quality and cut operating costs. And when you buy qualifying LED lamps or fixtures from a participating distributor, you can take advantage of instant discounts that reduce your purchase price.

Find the LED Lighting That's Right for You

Instant discounts are available for qualifying lamps or fixtures installed at an eligible existing commercial, industrial or multifamily (common areas only) site in Oregon that receives electrical service from Portland General Electric or Pacific Power. A participating distributor will verify the site address before applying the instant discount.

Here are just a few examples of LED lamps or fixtures available. These are examples only and actual products offered by participating distributors will vary.
