RFP section 3.2.9.1 Staffing Plan and Organizational Chart does not have any page limits provided. The remainder of the sub-sections in Part 9 equal 8 pages, which is listed as the page limit for that part in Table 2.	Plan and Qualifications. Please submit the Staffing Plan and Organizational Chart as an appendix.

In RFP section 3.2.7, it states: Other incentives such as early design assistance, technical studies and other technical assistance incentives should be built into "Energy Incentives" for Whole-Building Projects when preparing Appendix F: Pricing and Savings Proposal.  Is the reference to Energy Incentives correct or should studies and assistance incentives be included in "Service Incentives?" In RFP <b>section 3.2.3.1</b> Budget and Savings Goals Development, can you please clarify the reference to Energy Trust internal management costs?  Should the budget submitted include Energy Trust's internal management costs?	No. Bidders will not include any estimates of Energy Trust internal management costs in the submitted proposals. The reference in the RFP Section 3.2.3.1 is intended to alert Bidders to how Energy Trust develops its program budgets and how PMCs work with Energy Trust during the process. The portion of Bidder's submitted Part 3: Program Management narrative, as noted specifically in RFP Section 3.2.3.1, should demonstrate Bidder's experience and capabilities with Budget and Savings Goal Development.

Can you confirm that the proof of COBID or SBA certifications are not needed at the time of the proposal submittal date?	Bidders should provide proof (ex. certification #) for all certified COBID and/or SBA team members proposed for Supplier Diversity Spend Goal purposes. However, proof of certification is not required at the time of the RFP's Proposal Submittal deadline, on March 20, 2024, for those Bidder team members that have pending COBID or SBA applications in process. Energy Trust will consider COBID and SBA application status during the proposal review process due to the RFP's requirement that all COBID and/or SBA certifications need to be approved and verified by the listed RFP Schedule selection date, which is week of June 3, 2024.
